

## **American Medical Association Supplemental License Terms**

These American Medical Association (“AMA”) Supplemental License Terms, as amended from time to time (“AMA Supplemental Terms”), constitute the supplemental license terms of the AMA, as a third party vendor to Eyefinity, Inc., an intended third party beneficiary of the End User License Agreement (“License Agreement”) between Customer and Eyefinity. These AMA Supplemental Terms, together with all supplemental terms and exhibits found on [www.eyefinity.com/licensingexhibits.html](http://www.eyefinity.com/licensingexhibits.html), are hereby incorporated into the License Agreement for all of Eyefinity’s cloud based practice products, including EyefinityEHR, EyefinityPM, Acuity Logic, ExamWRITER, and Eyecon (“Eyefinity Product(s)”), without need for further action.

### **1. Grant of Rights, Restrictions, and Obligations:**

- (a) Eyefinity has obtained a nontransferable, nonexclusive license from the AMA, for the sole purpose of internal use by Eyefinity and/or Customer within the United States and Canada to “Editorial Content”. Editorial Content includes the data file(s) of *Current Procedural Terminology* (“CPT®”) including CPT® Standard and CPT® Link (formerly known as Developer’s Toolkit), all as available from the AMA (individually and collectively called “CPT Data File”) published by the AMA in the English language as used in the United States (collectively, “CPT” or “CPT® Editorial Content”), a coding work of nomenclature and codes for reporting of healthcare services.
- (b) Customer is prohibited from publishing, distributing via the Internet or other public computer based information system, creating derivative works (including translating), transferring, selling, leasing, licensing or otherwise making available to any unauthorized party the Editorial Content, or a copy or portion of Editorial Content.
- (c) Customer’s rights and obligations set forth herein are dependent on the continuing contractual relationship between Eyefinity and the AMA.
- (d) Customer shall cause any of its Users (as defined below) of Eyefinity Product(s) containing Editorial Content to comply with the provisions of these Supplemental Terms.
- (e) Users of Editorial Content are individuals who:
  - (i) accesses, uses, or manipulates CPT Editorial Content as applicable, contained in Eyefinity Product(s); or
  - (ii) accesses, uses, or manipulates Eyefinity Product(s) to produce or enable an output (data, reports, or the like) that could not have been created without the Editorial Content embedded in Eyefinity Products(s) even though Editorial Content may not be visible or directly accessible; or
  - (iii) makes use of an output of Eyefinity Product(s) that relies on or could not have been created without the Editorial Content embedded in the Eyefinity Product(s) even though Editorial Content may not be visible or directly accessible.
- (f) Upon request by Eyefinity, Customers shall accurately calculate and report to Eyefinity its Users of Editorial Content as contained in each Eyefinity Product(s) as applicable.

### **2. Notices**

- (a) Customer understands and acknowledges that CPT is copyrighted by the AMA and that CPT is a registered trademark of the AMA.
- (b) Customer understands and acknowledges that *Editorial Content is commercial technical data, which was developed exclusively at private expense by the American Medical Association (AMA), 330 North Wabash Avenue, Chicago, Illinois 60611. The AMA does not agree to license Editorial Content to the Federal Government based on the license in FAR 52.227-14 (Data Rights - General) and DFARS 252.227-7015 (Technical Data - Commercial Items) or any other license provision. The AMA reserves all rights to approve any license with any Federal agency.*

### **3. Back Up Rights**

- (a) Customer may only make copies of Eyefinity Product(s) for back up or archival purposes.
- (b) All notices of proprietary rights, including trademark and copyright notices, must appear on all permitted back up or archival copies made by Customer.

4. **Miscellaneous**

- (a) **Editorial Content as contained in Eyefinity Product(s) is provided “as is” without any liability to the AMA, including without limitation, no liability for consequential or special damages, or lost profits for sequence, accuracy, or completeness of data, or that it will meet the Customer’s requirements, and that the AMA’s sole responsibility is to make available to Eyefinity replacement copies of the Editorial Content if the data is not intact; and that the AMA disclaims any liability for any consequences due to use, misuse, or interpretation of information contained or not contained in Editorial Content.**
- (b) In the event a provision is determined to violate any law or is unenforceable the remainder of the License Agreement, including these AMA Supplemental Terms, will remain in full force and effect.
- (c) AMA is hereby a third-party beneficiary of the License Agreement.
- (d) Customer hereby grants Eyefinity permission to provide the AMA with Customer’s name solely to ensure compliance with the CPT Distribution License Agreement between AMA and Eyefinity.
