PURPOSE

A purchase will not improve your chances of winning. This Three-for-the-Dough ("**Drawing**") is offered to Eyefinity Practice Management and Eyefinity EHR customers to encourage business with Eyefinity's Education Conferences. Participating in the Drawing does not constitute entry into any other promotion, contest, or Drawing. By participating in The Drawing, each entrant accepts and agrees to comply with and abide by these Official Rules and the decisions of Eyefinity, Inc., 3100 Zinfandel Drive, Suite 600, Rancho Cordova, CA 95670 ("**Sponsor**"), which shall be final and binding in all respects.

ELIGIBILITY

The Drawing is open exclusively to those working at professional practices using Eyefinity Practice Management and Eyefinity EHR software located within the 50 United States and District of Columbia ("**Eligible Entrants**"). Void where prohibited, taxed, or restricted by law. Employees of the United States Federal Government and officers, directors, and employees of Sponsor and each its subsidiaries, affiliates, advertising and promotion agencies and the immediate family members and/or those residing in the same household of each are ineligible to enter the Drawing or win a prize.

The Lodge Drawing will commence on April 12, 2021 at 12:00 a.m. pacific time ("PT"). The Drawing will end on April 16, 2021 at 12:00 a.m. pacific time PT (the "**Promotion Period**").

How to Enter

Eligible Entrants must register for The Lodge by 12:00 a.m. (PT) on April 5, 2021 to qualify for an email invite to participate in the Drawing. Eligible entrants will receive an entry link via email to access and fill out basic contact information for the Drawing online. Eligible entrants will have several ways to gain entries throughout the Promotion Period.

- Entrants will gain one (1) entry for completing three activities in a row on the gameboard (horizontally, vertically, or diagonally)

Drawings

THE LODGE DRAWING WINNER NOTIFICATION

If, despite reasonable efforts, a potential winner does not respond within thirty (30) days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. ARBITRATION PROVISION: By participating in The Drawing, each entrant agrees that (1) any claim, dispute, or controversy (whether in contract, tort, or otherwise) the entrant may have against the Sponsor arising out of, relating to, or connected in any way with The Drawing, the awarding or redemption of any prize and/or the determination of the scope or applicability of this agreement to arbitrate, will be resolved exclusively by final and binding arbitration administered by JAMS and conducted before a sole arbitrator in accordance with the rules of JAMS; (2) this arbitration agreement is made pursuant to a transaction involving interstate commerce, and shall be governed by the Federal Arbitration Act ("FAA"), 9 U.S.C. §§ 1-16; (3) the arbitration shall be held in Sacramento, California; (4) the arbitrator's decision shall be controlled by the terms and conditions of these Official Rules and any of the other agreements referenced herein that the applicable participant may have entered into in connection with The Drawing; (5) the arbitrator shall apply California law consistent with the FAA and applicable statutes of limitations, and shall honor claims of privilege recognized at law; (6) there shall be no authority for any claims to be arbitrated on a class or representative basis, arbitration can decide only the entrant's and/or the applicable Sponsor individual claims; the arbitrator may not consolidate or join the claims of other persons or parties who may be similarly situated; (7) the arbitrator shall not have the power to award punitive damages against the entrant or any Sponsor; (8) in the event that the administrative fees and deposits that must be paid to initiate arbitration against any Sponsor exceed \$125 USD, and the entrant is unable (or not required under the rules of JAMS) to pay any fees and deposits that exceed this amount, Sponsor agrees to pay them and/or forward them on the entrant's behalf, subject to ultimate allocation by the arbitrator. If, however, subpart (6) is found to be invalid, unenforceable or illegal, then the entirety of this Arbitration Provision shall be null and void, and neither entrant nor Sponsor shall be entitled to arbitrate their dispute.
